Géza von Geyr was born in Germany in 1962. He graduated in modern history, ancient history, communication and in political science from the University of Munich. He also holds a doctoral degree (Dr. phil).

Géza von Geyr started his career in the Foreign Service as Desk Officer in the Political Directorate-General of the Federal Foreign Office (1993-1994), before taking up posts in Rabat (Head of the Legal, Consular and Cultural Section of the German Embassy) and Brussels (Desk Officer in the Directorate-General for External Relations at the European Commission). Upon returning to Germany in 2000, he worked in the European Directorate-General at the Federal Foreign Office.
